GENERAL INFORMATION

SCOPE

This Repair Parts Catalog lists all serviceable parts required for motor homes floor plans "A", "J" and "M" built by FMC/MCD. It is divided into functional groups as indicated on the frontispiece of this catalog. The functional group system used by FMC/MCD is designed to enable you to quickly find and order repair parts for your coach. For example, Group 9 "Brakes-Service," contains a complete listing of all serviceable brake parts used throughout the coach whether applied to the front or the rear brakes.

PART NUMBERS

FMC/MCD uses a 5 million series of numbers for item identification for both production and service of its vehicles. Items that are exclusively components of a purchased assembly use an R000 suffix added to the basic 5 million series part number. Included in the description of the part is a vendor code and number to further identify the part and assist in local purchase if necessary. The key to the vendor code is contained in this group.

ILLUSTRATIONS

Illustrations, keyed to the item description, are included where feasible to aid you in correct identification and selection. However, all items are not illustrated and a careful reading of the item description is recommended to keep ordering errors to a minimum.

QUANTITY

The quantity column indicates the total amount used per coach for that particular application rather than the quantity per assembly.

ORDERING PARTS

Repair parts can normally be ordered in either one of two ways. They can be obtained in "emergency" situations (where the vehicle is unable to be operated) from FMC/MCD by telephone to be followed with a Parts Order form to confirm the order. Or they can be ordered under normal situations for restocking of the Dealer's or Service Outlet's supply and for situations where the vehicle does not require the part for immediate repair to make it operable.

All repair parts will be shipped F.O.B., FMC/MCD Santa Clara, California Plant.

NOTE

Always provide model and serial number of coach and, if applicable, model and serial number of component for which part(s) is ordered.

EMERGENCY PARTS ORDER

When ordering repair parts on an "Emergency" basis, call FMC/MCD after you have filled out the Parts Order form number RVD-67 (refer to instructions given below). Be prepared to give the following information when placing the call by telephone:

- Sold to
- Shipping Address
- Routing
- Coach Serial Number and Model Number (if applicable)
- Odometer Reading (if applicable)
- Part Number(s)
- Description of Part(s)
- Quantity of Each Part
- Your Purchase Order Number
- Your Name (person ordering the parts)

Follow up by immediately sending the completed parts order to FMC/MCD. Make certain your Purchase Order number given over the telephone is identical to the one which appears on the confirming Parts Order to eliminate duplication of orders. Also write "Confirming Order" in the space at the bottom of the form just above the words "Subject to Terms On Reverse Side."

ROUTINE PARTS ORDER

Routine ordering of repair parts is accomplished by utilizing the same "Parts Order" form number RVD-67. Fill in all applicable blanks according to the instructions below and forward the original (top) copy to FMC/MCD. The second copy will be retained by the Dealer or Service Outlet as a record of the parts ordered. Be sure the form is signed and the purchase order number is included in the spaces provided.

1. Enter Dealer or Service Center purchase order number.
2. Enter date parts order form is prepared.

3. Enter name and address of Service Center or Dealer.

4. Enter address to which parts are to be shipped, only when address is different than in "sold to."

5. Enter name of carrier and indicate whether shipment is to be made surface or air.

6. Enter date parts are requested to arrive at destination.

7. For FMC/MCD use only.

8. Enter resale number.

9. Enter number of part being ordered.

10. Enter amount of each item being ordered.

11. Enter FMC/MCD part number (if available).

12. Enter name of part being ordered.

13. Enter Dealer or Service Center net price of each individual part.

14. Enter total price of line item.

15. Enter total parts prices.

16. Check appropriate box and enter tax, if any.

17. Enter total of number 15 and 16.

18. If parts are being ordered for a specific vehicle, enter vehicle model number.

19. If parts are being ordered for a specific vehicle, enter vehicle serial number.

20. Enter signature of authorized dealer or service center representative.

21. Enter each page number and total number of pages used for order.

All orders should be clearly printed. All orders and shipping dates will be confirmed by FMC/MCD. Forward all orders to:

PARTS RETURNED FOR CREDIT

Credit will be allowed for all new and unused repair parts providing the Dealer or Service Outlet has obtained prior approval from FMC/MCD. These parts must be returned to FMC/MCD, transportation prepaid. The invoice number and date on which the parts were originally purchased must be indicated when requesting credit for returned parts.

Credit will be made in accordance with prices established by the appropriate original parts invoice. A ten percent (10%) deduction to cover restocking may be imposed. Damaged or outdated parts will not be accepted for credit.
